In June 2026, voters within the Santa Clara Valley Open Space Authority boundaries approved the Measure D parcel tax, the Santa Clara Valley Wildfire Protection, Clean Water, and Open Space Act. The funds collected are used to restore and protect natural open spaces and waterways by managing land and creeks to reduce wildfires, floods, and water pollution, expanding trails, preserving family farms, and reducing illegal activity in open spaces. Property owners will pay \$0.02 per square foot of building area beginning July 1, 2026. The parcel tax will continue until it is ended by voters.

Measure D Parcel Tax Exemptions Available:

- Senior Exemptions: Property owners who are at least 65 years of age prior to July 1, 2026 and occupy the property as a principal residence
- Supplemental Security Income (SSI): Property owners receiving SSI for a disability regardless of age and occupy the property as a principal residence
- Social Security Disability Insurance (SSDI): Property owners who occupy the property as a principal residence and receive SSDI, regardless of age and whose yearly income does not exceed 250% of the 2012 federal poverty guidelines issued by the United States Department of Health and Human Services, as shown below:

How to Apply for the Measure D Exemption:

Complete the Measure D Exemption Application and include the following documentation (copies only).

- Ownership Verification: A current Property Tax Bill indicating your ownership of the property, and a copy of the grant deed and abstract/cover page if the property is held in a trust.
- Age Verification (Senior only): A valid California Driver's License or Identification Card, or Passport.
- Occupancy Verification: A current utility bill (electric or cable) in the applicant's name with service address.
- Benefits Verification Letter (SSI/SSDI only): A current Benefits Verification Letter may be obtained by calling the Social Security Administration at (800)772-1213.
- Income Documentation (SSDI only): Proof of income must be included with your application. Examples include legible income tax returns and payroll stubs.

Once you receive the SSI exemption, you are required to requalify annually by submitting an updated application form and providing an updated benefits verification letter to continue to receive the exemption.

Once you receive the SSDI exemption, you are required to requalify annually by submitting an updated application form and providing an updated benefits verification letter and income documentation to continue to receive the exemption.
